Comments

Legislation

- Candidates need to read the question carefully to ensure they understand the question and how to answer the question.
- Legible writing is a must in order for the examiners to read the answers.

Ventilation

- Candidates need to read the question carefully to ensure they understand the question and how to answer the question. It is the candidate responsibility to read the question thoroughly and answer the key points in detail.
- Legible writing is a must in order for the examiners to read the answers.
- If elements of the ventilation network appear to be impractical or you identify issues that would complicate the ventilating of the mine, candidates need to address this in their answer.
- Candidates need to give practical industry standard values and quantities (for example, daily tonnages and unit ventilation quantities) to validate their answers.

• Relatively easy marks can be obtained through marking up the mine plan provided, some candidates lost marks through lack of detail (poor use of ventilation device symbols and gas monitoring requirements).

Coal mining practice

- Candidates need to read the question carefully to ensure they understand the question and how to answer the question.
- Some candidates answered questions with an information dump without any organised structure to demonstrate the thought process and organisational skills required at a managers level.
- Some answers were too brief in answering the salient points; for example, when dealing with spontaneous combustion and indicators just mentioning CO or ratios is not enough information. What about the CO? When does the ratio become a concern? Candidates need to demonstrate knowledge and understanding of these and their application.
- Some candidates used generic or a motherhood statement approach to their answers which lacked detail of key points. This is not an adequate response to the question at mine manager level.
- Candidates need to adopt a comprehensive approach to their answers, giving knowledge of the entire
 operation not just individual tasks as an undermanager or coordinator would.

Comments

- The examination questions are real, practical and probable issues in the industry. Questions are not asked with the intention of entrapping the candidate.
- There was a distinct gap in knowledge between those who passed and the majority of those who did not pass.
- Those who passed demonstrated a sound knowledge of the areas required and the processes to be used from a manager's perspective with the selected questions.
- A variety of experience exposures including practical issues, management techniques and risk
 management would improve candidate's knowledge and confidence when undertaking these
 examinations.
